GLOSSARY

The following definitions shall apply to and are used in this Request for Qualifications:

“City” – refers to the *City of Hackensack*.

“Cost Proposal” –refers to a statement of Hourly Rates and costs for the services provided.

“Due Date” – refers to the date and time by which Qualification Statements must be received by the *City of Hackensack* in order to be considered for award of the Agreement or position.

“Qualification Statement” –refers to the complete responses to this RFQ submitted by the Respondents.

“Qualified Respondent” –refers to those Respondents who (in the Sole Judgment of the *City of Hackensack*) have satisfied the qualification criteria set forth in this RFQ.

“RFQ” – refers to this Request for Qualifications, including any amendments thereof or supplements thereto.

“Respondent” or **“Respondents”** –refers to the interested Firm(s) that submit a Qualification Statement.

SECTION 1

INTRODUCTION AND GENERAL INFORMATION

1.1. **Introduction and Purpose.**

NOTICE IS HEREBY GIVEN that the *City of Hackensack* is soliciting sealed Qualification Statements from interested persons and/or Firms for the provision of Professional Services and Extraordinary Unspecifiable Services in accordance with the “Fair and Open Process” pursuant to N.J.S.A. 19:44A-20.5, et seq. Through a Request for Qualification process described herein, persons and/or Firms interested in assisting the *City of Hackensack* with the Provision of such services must prepare and submit a Qualification Statement in accordance with the procedure and schedule in this RFQ. The *City of Hackensack* will review Qualification Statements only from those Firms that submit a Qualification Statement that includes all the information required to be included as described herein (in the Sole Judgment of the *City of Hackensack*). The *City of Hackensack* intends to qualify a person(s) and/or Firm(s) that (a) possesses the Professional, Financial and Administrative capabilities to provide the proposed services; and (b) will agree to work under the compensation terms and conditions determined by the *City of Hackensack* to provide the greatest benefit to the Taxpayers of the *City of Hackensack*. The *City of Hackensack* will consider Qualification Statements only from Individuals, Firms or Organizations that have demonstrated the capability and willingness to provide high quality services as required by the *City of Hackensack*. All appointments shall be made in accordance with all applicable Law.

1.2. **Procurement Process and Schedule.**

The selection of Qualified Respondents is not subject to the Bidding provisions of the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq. The selection is, however, subject to the “New Jersey Local Unit Pay-to-Play” Law, N.J.S.A. 19:44A-20.1, et seq. The *City of Hackensack* has structured a Procurement Process that seeks to obtain the desired results described above, while establishing a Competitive Process to assure that each person and/or Firm is provided an Equal Opportunity to submit a Qualification Statement in response to the RFQ. Qualification Statements will be evaluated in accordance with the criteria set forth in Section 5 of this RFQ, which will be applied in the same manner to each Qualification Statement received.

The Qualification Statements will be reviewed to determine if the Qualified Respondent has met the minimum Professional, Administrative, and Financial criteria described in this RFQ. Based upon the totality of the information contained in the Qualification Statement, including information about the reputation and experience of each Qualified Respondent, the *City of Hackensack* will (in its Sole Judgment) determine which Qualified Respondents are qualified (from Professional, Administrative, and Financial standpoints). Each Qualified Respondent that meets the requirements of the RFQ (in the Sole Judgment of the *City of Hackensack*) will be designated as a Qualified Respondent, and will be considered for selection by the *City of Hackensack*, in accordance with any applicable statute or governing regulation.

The RFQ process commences with the issuance of this RFQ. The steps involved in the process and the anticipated completion dates are set forth in Table 1, Procurement Schedule. The *City of Hackensack* reserves the right, among other things, to amend, modify or alter the Procurement Schedule upon notice to all Potential Qualified Respondents who have provided contact information to the City Clerk upon receipt of this RFQ.

All communications concerning this RFQ or the RFQ process shall be directed to the *City of Hackensack's* designated contact person, in writing.

Qualification Statements must be submitted to, and be received by, the *City of Hackensack*, via mail or hand delivery, by the Due Date. Qualification Statements will not be accepted by facsimile transmission or e-mail. Responses must be enclosed in a sealed envelope. The service provider must indicate the following on the outside of the envelope: (1) the name and address of the service provider; (2) the RFQ Reference Name and Title of the Services for which the response is submitted; and (3) “Sealed RFQ Response.” Responses may be delivered by hand, overnight courier or mail. The envelope containing the response must be received by the *City of Hackensack* by the date and time set forth above. No late responses will be accepted.

All Professional Service Contractors are required to comply with the requirements of N.J.S.A.52:32-44 (Business Registration of Public Contractors), N.J.S.A.10:5-31 et seq. and N.J.A.C.17:27 (Contract Compliance and Equal Employment Opportunities in Public Contracts).

Agreements will be awarded based on the most advantageous responses. In accordance with the Fair and Open Public Solicitation Process as set forth in N.J.S.A.19:44A-20.4 et seq., the *City of Hackensack* reserves the right to reject any or all submissions for any reason including, but not in any way limited to, any defects; or the *City of Hackensack*, in its Sole Discretion may waive formalities and accept any submissions that in their judgment will be in the best interest of the *City of Hackensack* and its users and member cities. The *City of Hackensack* shall award the Agreement or reject all submissions no later than sixty (60) days from receipt of same, unless extended with the consent of the Professional Service Responders (or Extraordinary Unspecifiable Services Responders). Proposals are being solicited through a Fair and Open process in accordance with N.J.S.A.19:44A-20.1, et seq. These Qualifications are being sought pursuant to the Local Public Contract Laws.

Subsequent to issuance of this RFQ, the *City of Hackensack* (through the issuance of Addenda to all Firms that have received a copy of the RFQ) may modify, supplement or amend the Provisions of this RFQ in order to respond to inquiries received from Prospective Qualified Respondents or as otherwise deemed necessary or appropriate by (and in the Sole Judgment of) the *City of Hackensack*.

Qualified Respondents are expected to examine the RFQ with care and observe all its requirements. All questions about the meaning or intent of this RFQ shall be submitted in writing no less than five (5) days prior to the due date of the Proposal. All interpretations and clarifications considered necessary by the *City of Hackensack's* representative in response to such comments and questions shall be responded to no less than five (5) days prior to the due date of the Proposal.

The *City of Hackensack* assumes no responsibility and liability for costs incurred by the Qualified Respondents prior to the issuance of an Agreement. The liability of the *City of Hackensack* shall be limited to the terms and conditions of the Agreement. Qualified Respondents will assume responsibility for all costs not stated in their Proposals. All unit rates either stated in the Proposal or used as a basis for its pricing are required to be all inclusive. Additional charges, unless incurred for additional work performed by request of the *City of Hackensack*, are not to be billed and will not be paid.

Any Agreement entered into between the Qualified Respondent and the *City of Hackensack* must be in accordance with and subject to compliance by both Parties with the New Jersey Local Public Contracts Law. The Qualified Respondent must agree to comply with the nondiscrimination provisions and all other Laws and Regulations applicable to the performance of services there under. The Qualified Respondent shall sign and acknowledge such forms and certificates as may be required by this section.

No Corporation or Partnership shall be awarded any Agreement for the performance of any work or the furnishing of any goods, unless, with receipt of the Proposal of said Corporation or Partnership, there is submitted a statement setting forth the names and addresses of all Stockholders in the Corporation or Partnership who own ten (10%) percent or greater interest therein. The Qualified Respondent shall complete and submit the form of statement that is included in this RFQ.

The *City of Hackensack* shall retain all of its rights and interest in any and all Documents and property both hard copy and digital furnished by the *City of Hackensack* to the Qualified Respondent for the purpose of assisting the Respondent in the performance of this Agreement. All such items shall be returned immediately to the *City of Hackensack* at the expiration or termination of the Agreement or completion of any related services, pursuant thereto, whichever comes first. None of the Documents and/or property shall, without the written consent of the *City of Hackensack*, be disclosed to others or used by the Qualified Respondent or permitted by the Qualified Respondent to be used by their parties at any time except in the performance of the resulting Agreement.

The *City of Hackensack* shall retain all of its rights and interest in any and all Documents and property both hard copy and digital furnished by the *City of Hackensack* to the Qualified Respondent for the purpose of assisting the Qualified Respondent in the performance of this Agreement. None of the Documents and/or property shall, without the written consent of the *City of Hackensack*, be disclosed to others or used by the Qualified Respondent or permitted by the Qualified Respondent to be used by their Parties at any time except in the performance of the resulting Agreement. The Qualified Respondent shall not have the right to use, sell, or disclose the total of the interim or final work products, or make available to third Parties, without the prior written consent of the *City of Hackensack*. Any information supplied to the *City of Hackensack* may be required to be supplied on CD/DVD or USB flash drive media compatible with Microsoft Windows, and Microsoft Office Suite 2010 or greater.

Termination: If, through any cause, the Qualified Respondent shall fail to fulfill in a timely and proper manner obligations under the Agreement or if the Qualified Respondent violates any requirements of the Contract, the *City of Hackensack* shall have the right to terminate the Agreement by giving written notice to the Qualified Respondent of such termination at least thirty (30) days prior to the proposed effective date of the termination, unless the Agreement contains more favorable terms to the *City of Hackensack*. Such termination shall relieve the *City of Hackensack* of any obligation for the balances to the Qualified Respondent of any sum or sums as set forth in the Agreement.

The right to reject any or all Proposals and to waive immaterial formalities is expressly reserved by the *City of Hackensack*.

1.3. Conditions Applicable to RFQ.

Upon submission of a Qualification Statement in response to this RFQ, the Qualified Respondent acknowledges and consents to the following conditions relative to the submission and review and consideration of its Qualification Statement:

- This Document is an RFQ and does not constitute an RFP.
- This RFQ does not commit the *City of Hackensack* to issue an RFP.
- All costs incurred by the Qualified Respondent in connection with responding to this RFQ shall be borne solely by the Qualified Respondent.
- The *City of Hackensack* reserves the right (in its Sole Judgment) to reject for any reason any and all responses and components thereof and to eliminate any and all Qualified Respondents responding to this RFQ from further consideration for this Procurement.
- The *City of Hackensack* reserves the right (in its Sole Judgment) to reject any Qualified Respondent that submits incomplete responses to this RFQ, or a Qualification Statement that is not Responsive to the requirements of this RFQ.
- The *City of Hackensack* reserves the right to supplement, amend or otherwise modify the RFQ through issuance of Addenda to all Prospective Qualified Respondents who have received a copy of this RFQ, and who have provided their contact information to the *City of Hackensack*.
- All Qualification Statements shall become the property of the *City of Hackensack* and will not be returned.
- All Qualification Statements will be made available to the Public at the appropriate time, as determined by the *City of Hackensack* (in the exercise of its Sole Discretion) in accordance with Law.
- The *City of Hackensack* may request additional information from Qualified Respondents, including requiring Qualified Respondents to send Representatives to the *City of Hackensack* for interviews.
- Any Qualification Statements not received by the *City of Hackensack* by the Due Date and Time will be rejected.
- Neither the *City of Hackensack*, nor its Respective Staffs, Consultants nor Advisors shall be liable for any claims or damages resulting from the solicitation or preparation of the Qualification Statement, nor will there be any reimbursement to Qualified Respondents

for the cost of preparing and submitting a Qualification Statement or for participating in this Procurement Process.

1.4. Rights of City

The *City of Hackensack* reserves, holds and may exercise, at its Sole Discretion, the following rights and options with regard to this RFQ and the Procurement Process in accordance with the Provisions of applicable Law:

- To determine that any Qualification Statement received complies or fails to comply with the terms of this RFQ.
- To supplement, amend or otherwise modify the RFQ through issuance of Addenda to all Prospective Qualified Respondents who have received a copy of this RFQ, and who have provided their Contact information to the *City of Hackensack*.
- To waive any technical non-conformance with the terms of this RFQ.
- To change or alter the schedule for any events called for in this RFQ upon the issuance of notice to all Prospective Qualified Respondents who have received a copy of this RFQ.
- To conduct investigations of any or all of the Qualified Respondents, as the *City of Hackensack* deems necessary or convenient, to clarify the information provided as part of the Qualification Statement and to request additional information to support the information included in any Qualification Statement.
- To suspend or terminate the Procurement Process described in this RFQ at any time (in its Sole Discretion). If terminated, the *City of Hackensack* may determine to commence a new Procurement process or exercise any other rights provided under applicable Law without any obligation to the Qualified Respondents.
- To procure the Professional Services and/or Extraordinary Unspecifiable Services described herein at any date or time, not to exceed One (1) Year, subsequent to the Qualification Statement Due Date.

The *City of Hackensack* shall be under no obligation to complete all or any portion of the Procurement Process described in this RFQ.

1.5. Addenda or Amendments to RFQ.

During the period provided for the preparation of responses to the RFQ, the *City of Hackensack* may issue Addenda, amendments or answers to written inquiries. Those Addenda will be provided by the *City of Hackensack* to all Qualified Respondents who have provided the *City of Hackensack* with their contact information, and will constitute a part of the RFQ. All responses to the RFQ shall be prepared with full consideration of the Addenda issued prior to the submission due date.

1.6. Cost of Qualification Statement Preparation.

Each Qualification Statement and all information required to be submitted pursuant to the RFQ shall be prepared at the sole cost and expense of the Qualified Respondent. There shall be no claims whatsoever against the *City of Hackensack*, its staff or consultants for reimbursement for the payment of costs or expenses incurred in the preparation of the Qualification Statement or other information required by the RFQ.

1.7. Qualification Statement Format.

Responses should cover all information requested in the Questions to be answered in this RFQ. Responses which in the judgment of the *City of Hackensack* fail to meet the requirements of the RFQ or which are in any way conditional, incomplete, obscure, contain deletions from requested information, or contain errors may be rejected.

1.8. Cost Details:

- Service fees and/or hourly rates of each individual who will perform the services for the Zoning Board.
- Time estimates for each service to be performed for each individual and all related expenses {NOTE: Travel time and mileage are not eligible expenses and will not be paid}
- Total annual Non-Escrow “Not to Exceed” amount for Legal Counsel Services relating to Zoning Board application review, Zoning Board procedures and other Projects generally handled by Zoning Boards that cannot be billed to an Escrow Account. {NOTE: Travel time and mileage are not eligible expenses and will not be paid}

SECTION 2

SCOPE OF SERVICES

The *City of Hackensack* seeks to award Agreements for the positions listed below. The Agreement shall be Open-Ended, and may encompass additional work during the course of the year not explicitly described herein. It is the intent of the *City of Hackensack* to solicit Qualification Statements from Qualified Respondents that have expertise in the Provision of the services required by the position or Agreement sought. Firms and/or persons responding to this RFQ must be able to demonstrate that they will have the continuing capabilities to perform these services.

- **Zoning Board of Adjustment Engineer**
- **Zoning Board of Adjustment Planner**

SECTION 3

SUBMISSION REQUIREMENTS

3.1. **General Requirements.**

The Qualification Statement submitted by the Qualified Respondent must meet or exceed the Professional, Administrative, and Financial Qualifications set forth in this Section 3 and shall incorporate the information requested below. An **Original (1) and Eight (8) copies of the Qualification Statement and all attachments are to be submitted by each Qualified Respondent in response to this RFQ.**

In addition to the information required as described below, a Qualified Respondent may submit supplemental information that it feels may be useful in evaluating its Qualification Statement. This information may include Documents such as a Firm profile or brochure. Qualified Respondents are encouraged to be clear, factual, and concise in their presentation of information.

3.2. **Administrative Information Requirements.**

The Qualified Respondent shall, as part of its Qualification Statement, provide the following documentation and information:

1. An executive narrative summary (not to exceed two (2) pages) of the information contained in all the other parts of the Qualification Statement.
2. An Executed Letter of Qualification (See Appendix “A” to this RFQ).
3. An Executed Letter of Intent (See Appendix “B” to this RFQ).
4. Name, address, and telephone number of the Firm or Firms submitting the Qualification Statement pursuant to this RFQ, and the name of the key contact person for this RFQ.
5. A description of the Business Organization (i.e., Corporation, Partnership, Joint Venture, etc.) of each Firm, its Ownership, and its Organizational Structure.
 - (a) Provide the Names and Business addresses of all Principals of the Firm or firms submitting the Qualification Statement. For purposes of this RFQ, the term “Principals” means persons possessing an Ownership interest in the Qualified Respondent. If the Qualified Respondent is a Corporation, “Principals” shall include each investor who would have any amount of operational control over the Qualified Respondent and every Stockholder having an Ownership interest of ten (10%) percent or more in the Firm.
 - (b) If the Firm is a partially owned or a fully-owned subsidiary of another Firm, identify the parent company and describe the nature and extent of the parent’s approval rights over the activities of the Firm submitting a Qualification Statement. Describe the approval process.
 - (c) If the Qualified Respondent is a Partnership or a Joint Venture or similar Organization, provide comparable information as required in (a) and (b) above for each member of the Partnership, Joint Venture or similar Organization.
6. A statement that the Qualified Respondent has complied with all applicable Affirmative Action (or similar) requirements with respect to its business activities (e.g. N.J.S.A. 10:5-31, et seq. and N.J.A.C. 17:27 as amended) together with evidence of such compliance.

7. The number of years Qualified Respondent has been in business under the present name.
8. The number of years Qualified Respondent has been under the current management. If Qualified Respondent is a Corporation, please provide a current list of Corporate Officers.
9. Any judgments within the last three (3) years in which Qualified Respondent has been adjudicated liable for Professional malpractice. If yes, please provide a recitation of the Docket Numbers.
10. Whether the Business Organization is now or has been involved in any bankruptcy or re-organization proceedings in the last ten (10) years. If yes, please provide a recitation of the docket numbers.
11. Confirm and provide copies of the appropriate Federal and State licenses to perform the services required by the position or Agreement for which this RFQ is made.
12. A copy of the Qualified Respondent's State of New Jersey Business Registration Certificate.
13. A completed Business Entity Disclosure Certification, in accordance with the State of New Jersey's Pay-to-Play laws, N.J.S.A. 19:44A-1, et seq.
14. Completed RFQ Documents annexed hereto.

3.3. Professional Information Requirements.

1. Qualified Respondent shall submit a description of its overall experience in providing the type of services sought in the RFQ. At a minimum, the following information on past experience should be included as appropriate to the RFQ:
 - (a) Description and scope of work by Qualified Respondent;
 - (b) Name and contact information for any references; and
 - (c) Explanation of perceived relevance of the experience to the RFQ.
2. Describe the services that Qualified Respondent would perform directly.
3. Describe those portions of the Qualified Respondent's services, if any, that are Sub-contracted out. Identify all Subcontractors the Qualified Respondent anticipates using in connection with the position or Contract for which this RFQ is made.
4. Professional history of all individuals whom Qualified Respondent anticipates performing the Professional Services or Extraordinary Unspecifiable Services required by the position or Contract for which this RFQ is made.
5. A narrative statement of Qualified Respondent's understanding of the *City of Hackensack's* needs and goals to be accomplished by the appointment or Contract for which this RFQ is made.
6. List all immediate relatives of Principal(s) of Qualified Respondent who are *City of Hackensack* Employees or Elected Officials of the *City of Hackensack*.

(For purposes of the above, "Immediate Relative" means a spouse, parent, step-parent, brother, sister, child, step-child, direct-line aunt or uncle, grandparent, grandchild, and in-laws.)

SECTION 4

To be Responsive, Qualification Statements must provide all requested information, and must be in strict conformance with the instructions set forth herein:

1. Qualification Statements must be received by the *City of Hackensack* no later than the Due Date, and must be mailed or hand-delivered. Qualification Statements forwarded by facsimile or e-mail will not be accepted. Qualification Statements received after this time will not be considered. The *City of Hackensack* will not bear responsibility for delays in delivery for any reason.
2. Qualification Statements and all related information must be stapled or bound, and signed by the Qualified Respondent. If Qualified Respondent is other than a natural person, the Qualification Statement must be signed by an individual with power to bind Qualified Respondent.
3.
